ARTICLES OF INCORPORATION

OF

The undersigned subscriber to these Articles of Incorporation, being an attorney duly licensed to render legal services under the laws of the State of Florida, hereby presents these Articles of Incorporation for the formation of a professional service corporation under F. S. Chapter 621, and other laws of the State of Florida

ARTICLE I. NAME

The name of the corporation is Jaana T. Moisio, P.A.

ARTICLE II. PRINCIPAL OFFICE

The principal office and mailing address of the corporation is 5692 B. Fox Hollow Drive, Boca Raton, Florida 33486.

ARTICLE III. PURPOSE

This corporation is formed to engage in every phase and aspect of the practice of law. In addition, this corporation may invest the funds of the corporation in real estate, mortgages, stocks, bonds or any other type of investment, and may own real and personal property necessary for the rendering of professional services. The foregoing shall be construed as enumerating both objects and purposes of the corporation. The foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the corporation otherwise permitted by law.

NO shareholder of the corporation may sell or transfer stock in the corporation except to another individual who is eligible to be a shareholder of the corporation, and the sale or transfer may be made only after it has been approved at a shareholders' meeting specifically called for that purpose.

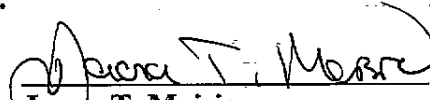
ARTICLE XI. AMENDMENT

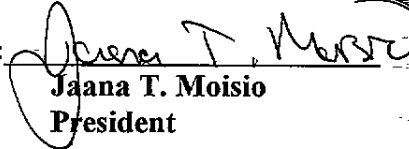
