The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopt the following Articles of Incorporation:

### **ARTICLE I – NAME/PRINCIPAL PLACE OF BUSINESS**

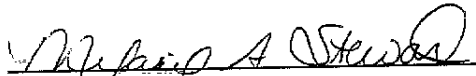

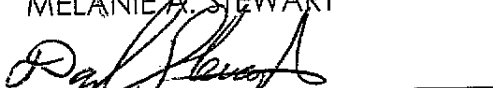
