CORPORATE NAME**

The duration of the Corporation shall be forever or until dissolved.

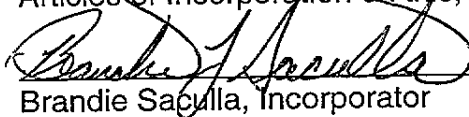

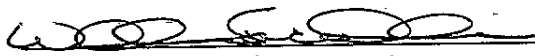
