# ARTICLES OF INCORPORATION

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPTS THE FOLLOWING ARTICLES\_OF INCORPORATION:

# ARTICLE I. NAME

# ARTICLE II. PRINCIPAL PLACE OF BUSINESS
