

**Article I
Name and Principal Place of Business**

The name of this corporation is CHEAPHOMEFINDER.COM, Inc. The principal place of business and mailing address of the corporation is 7015 SW 134th Avenue, Archer, Florida 32618.

**Article II
Purposes**

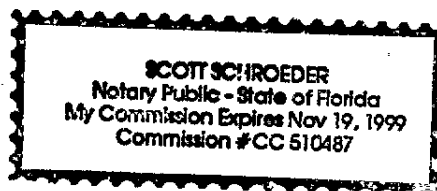
