"ARTICLE I - NAME OF CORPORATION

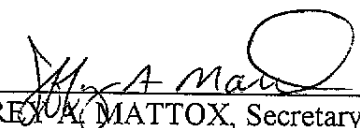

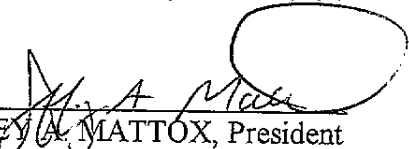
