ARTICLE I - NAME

The name of this Corporation is **JUDITH WIBEL, P.A.**

ARTICLE II - PRINCIPAL OFFICE

The Corporation shall have a perpetual existence.



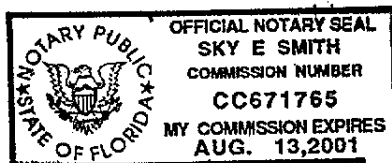


