- 1. The name of the corporation is Prevention Recovery Network, Inc.

- 4. The amendment to the corporation's Articles of Incorporation was adopted and approved by all of the stockholders of the corporation, which approval is sufficient for the amendment's adoption and approval.
- 5. The effective date of the amendment is to be the date of filing this Certificate of Amendment with the Secretary of State.
