ARTICLE ONE

The name of the corporation is **VAL'S PEST CONTROL, INC.** The principal address of the corporation is: 2400 W. BROWARD BLVD. LOT 606 FORT LAUDERDALE, FLORIDA 33312.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE
