ARTICLE I. NAME AND ADDRESS

ARTICLE II. DURATION AND COMMENCEMENT

This corporation shall exist perpetually and shall commence on the date of execution and acknowledgment of these Articles.

ARTICLE III. PURPOSES

This corporation is organized for the following purposes:

1. To own and operate a fully mobile custom applied truck bed liner business for commercial customers in the truck sales industry.
