ARTICLES OF INCORPORATION

**SECRETARY OF STATE

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I
NAME**

The name of the corporation ("Corporation") is DOCTORS REIMBURSEMENT SPECIALISTS, INC.

**ARTICLE II
COMMENCEMENT OF EXISTENCE AND DURATION**

The existence of the corporation shall begin on May 1, 1999 and shall have perpetual existence unless sooner dissolved according to law.

**ARTICLE III
PURPOSE**

The Corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of Florida.

**ARTICLE IV
PRINCIPAL OFFICE**

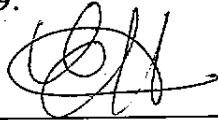

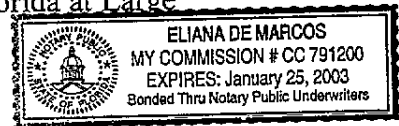

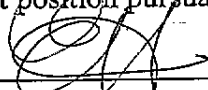
