ARTICLE I

CORPORATE NAME

The name of this corporation is: Susie Steele, Inc.

NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this corporation is an insurance agency. The corporation shall have all powers afforded by the State of Florida


ARTICLE IX




