**ARTICLES OF INCORPORATION**

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**I**

The name of the corporation shall be *MONARD MARKETING, INC.*, The principal place of business shall be 4252 N. Orange Blossom Tr., Orlando, Fl. 32804

**II**

The duration of this corporation is perpetual unless dissolved according to law.

**III**

The purposes for which this corporation is organized are:

- I. To conduct a marketing business to the general public.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporations Act.
3. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.

**IV**

(500). Such shares shall be of a single class, and shall have a par value of ten dollars (\$10.00) per share.



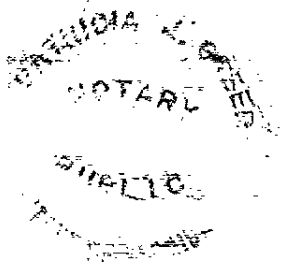
