(hereinafter, “Corporation”).”

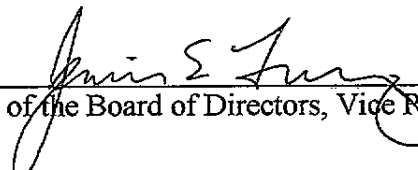
