ARTICLES OF INCORPORATION OF PET PLANET, Inc.

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, does hereby adopt the following articles of incorporation:

ARTICLE 1: NAME OF CORPORATION

The name of the corporation is Pet Planet, Inc.
