#### ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is JOSE LUIS MARTINEZ, M.D., P.A. Its principal office and mailing address is 2140 West 68 Street, Suite 300, Hialeah, Florida 33016.

#### **ARTICLE II - DURATION**

The effective date of this Corporation shall be May 5, 1999, and it shall exist perpetually thereafter unless sooner dissolved according to law.

#### <u>ARTICLE III - PURPOSE</u>

The purpose of this Corporation is to provide medical services and to engage in any activities permitted under the laws of the United States and the State of Florida, in accordance with Chapter 621, Florida Statutes, and any successor statute or law.

#### ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$.10 per share.

# ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation shall be The Colonnade, Suite 710, 2333 Ponce de Leon Boulevard, Coral Gables, Florida 33134, and the initial registered agent of this Corporation at such office shall be Juan C. Martinez, who upon accepting this designation agrees to comply with the provisions of Chapters 48 and 607, Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process.
