OF

ARTICLE I - NAME

The name of this corporation is _____

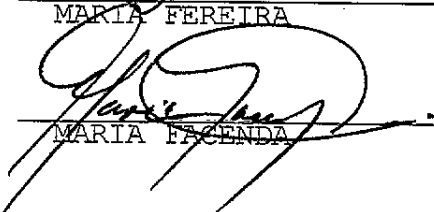
