ARTICLES OF INCORPORATION

FOR

FAMILY PHYSICIANS OF TAMPA, INC.

The undersigned incorporators, for the purpose of forming a corporation under Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I - NAME AND PURPOSE OF CORPORATION

The name of the corporation shall be FAMILY PHYSICIANS OF TAMPA, INC. The purpose of the corporation shall be for the business administration of the medical clinic, Family Physicians of Tampa, Inc. and not for the purpose of providing personal medical services.

ARTICLE II - PRINCIPAL OFFICE






