

ARTICLE 1. - NAME

The name of the corporation is CIRCLE PARTNERS OF SARASOTA, INC.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 478 John Ringling Blvd., Sarasota, FL 34236. The corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

ARTICLE 4. - PURPOSE


