ARTICLES OF INCORPORATION

of

PRECESSION SERVICES OF AMERICA, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the Corporation shall be: **Precession Services of America, Inc.**

The principal place of business of this Corporation shall be at 6001 Johns Road, Suite 637, Tampa, Florida 33634.

ARTICLE II NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other state, country, territory or nation.

ARTICLE III CAPITAL STOCK

The Corporation is authorized to issue 100 shares of common stock having par value of \$1.00 per share.

ARTICLE IV INITIAL REGISTERED OFFICE AND AGENT

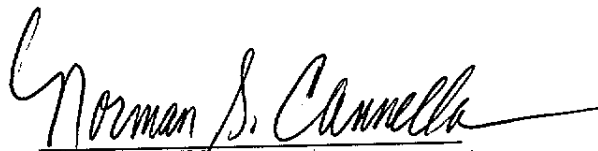
