ARTICLES OF INCORPORATION

OF

ACTIVEOUTDOORS.COM, INC.

The undersigned, for the purpose of forming a corporate on under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of this corporation is ACTIVEOUTDOORS.COM, INC., with its principal office located at 6063 Sabal Creek Boulevard, Port Orange, Florida, 32122.

ARTICLE II

This corporation shall have perpetual existence.

ARTICLE III

The general nature of the business to be transacted by this corporation is as follows:

- (a). To transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
