TRUMAN J. COSTELLO, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for WEBCO ENTRY SYSTEMS, INC.

ARTICLE I
(Name)

The name of the corporation shall be: WEBCO ENTRY SYSTEMS, INC.

ARTICLE II
(Duration)

The period of its duration is perpetual.

ARTICLE III
(Nature of Business)

The aggregate number of shares which the Corporation shall

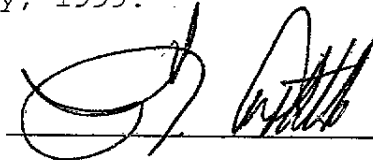

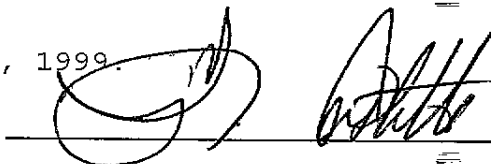
