The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation.

FIRST: The name of the Corporation is GUNTERT CORPORATION.

SECOND: The period of duration of the Corporation is perpetual.

THIRD: The general purpose for which this Corporation is organized is to transact and engage in any activity or business permitted under the Laws of the United States and the State of Florida; except that it is not to conduct banking, safe deposits, telephone, or cemetery company, a building and loan association, or other things as are incidental to the foregoing or necessary, or desirable in order to accomplish the foregoing.

FOURTH: Authorized Shares.

Number: The aggregate number of shares that the Corporation shall have the authority to issue is 500 shares of Capital Stock with a par value of \$1.00 per share.

Stated Capital: The sum of the par value of all shares of Capital Stock of the Corporation that have been issued shall be the stated capital of the Corporation, at any particular time.

Dividends: The holders of the outstanding Capital Stock shall be entitled to receive, when as declared by the Board of the Directors, dividends payable either in cash, property or in shares of Capital Stock of the Corporation.

No Classes of Stock: The shares of the Corporation are not divided into classes.

No Shares in Series: The Corporation is not authorized to issue shares in series.
