ARTICLES OF INCORPORATION

The undersigned hereby forms a corporation under the following Charter of Articles of Incorporation:

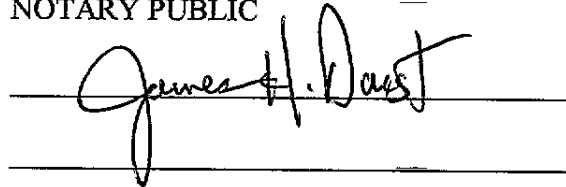

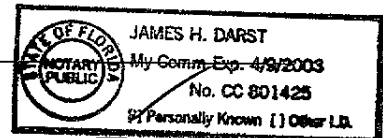
