



Dear Sir or Madam:

Please review the attached 2003 UBR(s), with changes, filed on behalf of my clients, Envirotech Air Quality Services, Inc., and Good Car Corporation. This letter is a formal request for an exception to the \$400.00 additional late filing fee, charged when a UBR is filed past the due date. I believe that an exception is warranted in this case, due to some recent events in Mr. Tom Smith's personal life, which have caused extreme stress, and have resulted in a lapse in his business management responsibilities. Mr. Smith has been the only Officer/Director of both companies in the last year, and was the only person with the authority to complete an accurate UBR.

To elaborate, Mr. Smith's daughter, Kelly was admitted to the hospital approximately two-months ago, and was in the Bethesda Memorial Hospital ICU unit for almost two-weeks, very close to death. A staff infection brought her to the hospital originally, and spread throughout her body, causing the shut-down of major organs. Kelly was released from the hospital approximately two-weeks after leaving ICU, and now requires around-the-clock assistance, and daily physical therapy, along with follow-up operations to remove non-essential, damaged internal organs. To say the least, these last months have been extremely trying for Mr. Smith, causing a lack of focus on his business activities.

At this time, Envirotech will be replacing Mr. Smith as Director, and appointing his elder daughter, Tracy as President of the corporation. Mr. Smith is stepping down, and taking care of the matter above, and other family matters. Mr. Smith is retaining his status as President of Good Car Corporation, but is adding Tracy Smith as Secretary, and handing over the day-to-day operations of Good Car to her at this time for the same reasons stated above.

During these last months, Envirotech, Good Car, and the Smith's have suffered monetary difficulties due to the aforementioned issues. I ask that you provide them with this exception, so not to add to their already trying times. Upon receiving approval of an exception, a check for the \$150.00 fee for each corporation will be sent immediately (overnight if necessary). I truly thank you for your consideration of this request.
