ARTICLES OF INCORPORATION

The By-Laws of this corporation may be adopted, altered, amended or repealed by either the Shareholders or Directors.

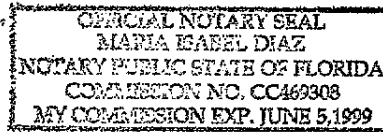
