

The undersigned for the purpose of forming a corporation under the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Company Act, does hereby adopt the following articles of incorporation.

ARTICLE I- NAME

The name of the corporation is MOHAMMED G. CHOUDHURY, M.D., P.A.

ARTICLE II- CORPORATE DURATION

The duration of the corporation is perpetual.

ARTICLE III- INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of the corporation is 302 South Marion Street, Suite C-1, Lake City, Florida 32025.

ARTICLE IV- CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 1,000 shares of common stock, having a par value of \$1.00 per share, fully paid and non-assessable.

Authorized capital stock may be paid for in cash, services, or property, at a just value, but not less than par value, to be fixed by the Board of Directors of this corporation.

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V- REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the corporation is 302 South Marion Street, Suite C-1, Lake City, Florida 32025. The initial registered agent of the corporation at such office is Mohammed G. Choudhury.

ARTICLE VI- DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time as provided in the By-Laws, but shall never be less than one (1).

ARTICLE VII- INITIAL BOARD OF DIRECTORS


