ARTICLES OF INCORPORATION

OF

WEBWORLD, INC.

The undersigned incorporator hereby forms a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is Webworld, Inc.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE III

CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock, to be designated as Common Stock. INCORPORATOR


