ARTICLE I - NAME

The name of this corporation is GLOBAL JET ALLIANCE, INC. (the "Corporation").

ARTICLE X - INITIAL BOARD OF DIRECTORS

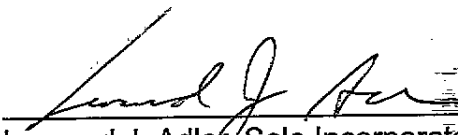
