#### Article I - Name

The name of this corporation is Standing Room Only Sports & Entertainment, Inc.

Article III - Commencement

This corporation shall commence on the date of execution and acknowledgement of these Articles.

#### Article IV - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

#### Article V - Capital Stock

This corporation is authorized to issue 10,000 shares of \$0.001, par value, common stock.
