The name of the corporation shall be NEW CREATION RECOVERY, INC.

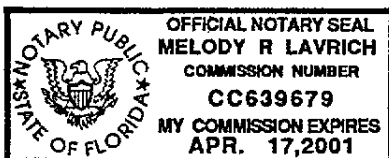
