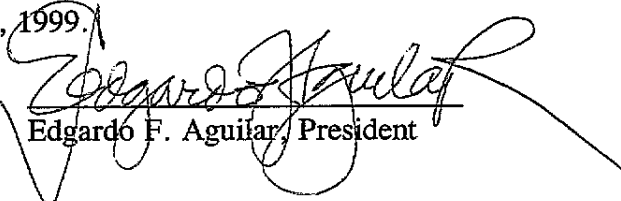
ARTICLE XI.

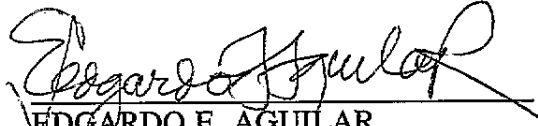

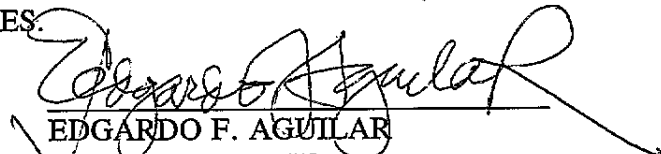
