**ARTICLES OF INCORPORATION
OF
ALAN VANDETTI GRADING, INC.**

The undersigned acting as incorporator of a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - NAME

The name of the corporation is Alan Vandetti Grading, Inc. The mailing address of the corporation is 695 100th Ave. N., Naples, Florida 34108.

ARTICLE II - PRINCIPAL OFFICE

The street address of the principal office of this corporation is, 695 100th Ave N., Naples, Florida 34108.

ARTICLE III - COMMENCEMENT AND DURATION

The corporation is to commence its corporate existence on the date of filing, and shall exist perpetually thereafter until dissolved according to law.

ARTICLE IV - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business.
