ARTICLE I. NAME

ARTICLE V. TERM OF EXISTENCE

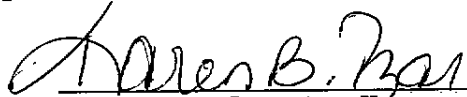
