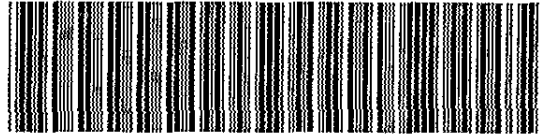

The Articles of Amendment to the Articles of Incorporation of HORIZON IN-STORE SERVICES OF FLORIDA, INC. FIRST: ARTICLE I - NAME: The name of the Corporation is:

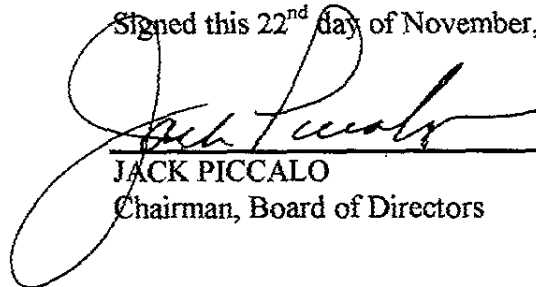
PIC SALES, INC.
