
To Whom It May Concern:

Broward Precision Manufacturing, Inc. is a Florida Corporation incorporated in Broward County. The company has been in operation for three years under this same name. The company has kept the same physical and mailing address throughout the term of its incorporation. Due to reasons yet undetermined, the company has never received an application for the Uniform Business Report filing. I believe at this time that if the renewal form was sent in the mail it may have been lost due to no fault of Broward Precision Manufacturing, Inc. or, for other unknown reasons, we have just not received it.
