ARTICLES OF INCORPORATION

#### ARTICLE I

The name of this corporation is G. K. INTERNATIONAL CORP.

#### ARTICLE II

This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these articles or if these articles should not be filed within fifteen days of execution, then upon filing with the Secretary of State.

#### ARTICLE III

This corporation is organized for the purpose of engaging in all aspects of the janitorial contracting service business and any and all other lawful business.

These shares nor any part hereof shall be sold or otherwise transferred to any person other than the person to whom originally issued, his or her heirs, executors or administrators, unless first submitted to G. K. INTERNATIONAL CORP., (the Company) for redemption at the then fair market value. In the event that the Company shall fail or refuse to redeem such shares within ninety days following the tender thereof to the Company, then and in that event, the person to whom such shares were originally issued shall be authorized to dispose of such shares or any part thereof in any manner permitted by law. No transfer or any shares shall be valid, however, unless entered in the records of the Company

The transfer of any shares of stock hereafter issued shall not be effective unless approved in writing by the stockholders.

#### ARTICLE XVII - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these articles of incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
