**ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

**Article I
Name**

Section 1.1. Name. The name of this corporation shall be Alliance Corporate Health Services, Inc.

**Article II
Principal Office and Mailing Address**

Section 2.1. Principal Office and Mailing Address. The principal place of business address of this corporation shall be 4241 Baymeadows Road, Suite 14, Jacksonville, Florida 32217. The mailing address of this corporation shall be 11111-2A San Jose Boulevard #284, Jacksonville, Florida 32223.

**Article III
Capital Stock**

Section 3.1. Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$1.00 per share.
