I wish to pursue this issue, because I thought that by sending a letter to you stating that I did not receive the Annual Report, you would at least contact me to talk to a real person. I tried your number of 850-245-6056, and got automated voices throughout.

I DID NOT RECEIVE THE ANNUAL BUSINESS REPORT for 2003. I normally do receive it and pay the \$150 accordingly each year. However, since it did not arrive, I did not think to look it up and ask for it. So, how could I have paid it if I didn't even realize it was not here?

I had to forego some of my business this past May, June, & July, due to being a healthcare surrogate for a dying woman. I have not had my brain in the right place for quite some time. I will simply ask you to forgive this "late fee" since I did not receive it, number one; and number two, why would I not pay it in the first place, having to hassle over \$400 more in late fees? That's just plain stupid. Of course I would pay the \$150 instead of \$550. Please, please, please call me and talk to me about this - a real person, please!


To Whom it May Concern:
