**ARTICLES OF INCORPORATION
OF
ROBBIN'S COMPLETE AUTO REPAIR & RADIATOR, INC.**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act hereby adopt the following articles of incorporation:

ARTICLE I

NAME

The name of the corporation is **ROBBIN'S COMPLETE AUTO REPAIR & RADIATOR, INC..**

ARTICLE II

DURATION

The term of existence of the corporation is perpetual.

ARTICLE III

PURPOSE
