ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, Hereby adopts the following Articles of Incorporation:

ARTICLE I – NAME

The name of this corporation is FINER LAWNS & GARDENS, INC.

ARTICLE II – PURPOSE

ARTICLE XI – SUB–CHAPTER S CORPORATION


This corporation may elect to be treated as a Sub–Chapter S Corporation as defined by the Internal Revenue Code.






