ARTICLES OF INCORPORATION

OF

FARLEY INSURANCE SERVICE INC.

In compliance with the requirements of *Florida Statutes* Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is FARLEY INSURANCE SERVICE INC.

**ARTICLE II**

The existence of the corporation shall begin upon the filing of these Articles with the Florida Department of State, Division of Corporations.

**ARTICLE III**




