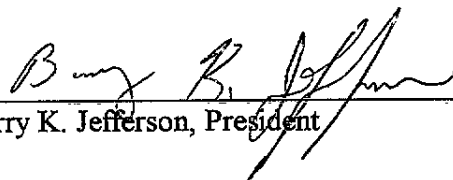
ARTICLE IX - AMENDMENT
