The name of this corporation is Kendall Crossings Approval Committee, Inc.

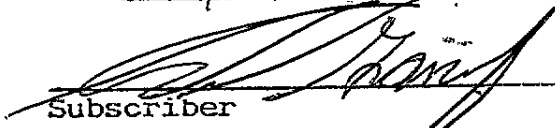

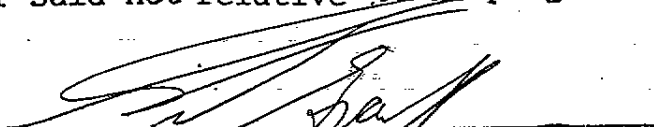
