ARTICLE I.

EFFECTIVE DATE

NAME

The name of this corporation is A & F ENTERPRISES OF JACKSONVILLE, INC.

ARTICLE II.

PRINCIPAL OFFICE

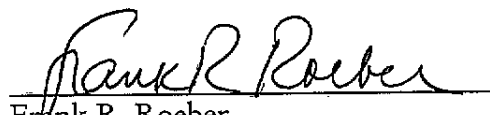

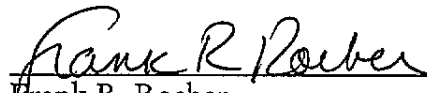
