

We just received notice of Administrative Dissolution of Subject Corporation. We kindly request reinstatement without having to pay \$750.00 surcharge due to reasonable cause.

In early 2002 John & Barbara Davis moved from Spring Hill, FL on the West Coast over to the East Coast in Coral Springs, FL. Unfortunately, the Annual Report and later notices sent by the State were not forwarded. Otherwise, there would be no reason for the non-payment of the regular \$150.00 annual fee.

It appears that the Post Office finally returned to the State the earlier mailings because your records now reflect the correct address, 11101 Heron Bay Blvd. Apt 4916, Coral Springs, FL 33076-1636.
