


ARTICLE VIII

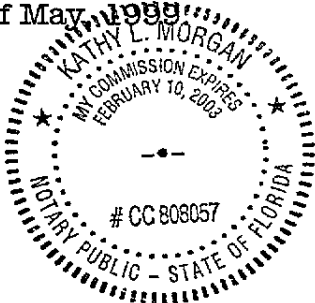





