Please reinstate our company, Lawbuck Apartments, Inc., a Florida corp. Enclosed please find:

1. 2002 UBR for Lawbuck Apartments, Inc.;
2. Letter from Dept of State acknowledging receipt of \$150 check;
3. Attorneys Trust Account Check for \$150.00 for 2002 Annual Report;
4. Attorneys Trust Account Check for \$8.75 Certificate of Status;
5. Letter from Secretary of State, dated April 26, 2002; and,
6. Letter from Corporation, dated April 10, 2002.

On April 10, 2002, Lawbuck Apartments, Inc., sent in a letter with a check for \$150 for the 2002 annual report without the form UBR, since it had not received same at its Florida mailing address. Upon investigation concluded today it appears that the Division of Corporations did not mail the UBR to the corporation's mailing address, but instead used the Corporation's address in Montego Bay, Jamaica (which explains in part why none of the correspondence from Tallahassee was delivered to the corporation). The end result was that until today Lawbuck Apartments, Inc., had never received its UBR or any correspondence because the secretary of state did not use the Florida mailing address, but instead mailed the documents to Montego Bay, Jamaica. Today I was able to speak with Ms. Uela in Corporation Reinstatements who explained how to Download the UBR and who faxed me the April 26, 2002 Division of Corporation letter acknowledging receipt of the check and correspondence of April 10, 2002. It is a blessing to have such knowledgeable people working in Tallahassee to help resolve these problems. Please thank her supervisor.

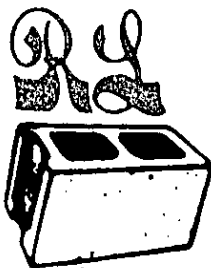
I believe that you are still holding Lawbuck Apartments Inc., check no. 1665 in the amount of \$150.00 for its original annual report (please see Corporation letter dated April 10, 2002 and Secretary of State confirmation letter of April 26, 2002); however, I am re-submitting my attorney's trust account check in the amount of \$150.00 in the event the prior check cannot be located. I respectfully request that you not charge the \$400 late fee because your correspondence was not received until today, and technically the 30 days has just started to run; additionally, the error in not receiving the UBR and your correspondence was due to the Secretary of State's error in not utilizing the Florida mailing address. However, if you require the \$400 late fee, please call me and I will provide my VISA charge, or I will overnight my attorney's trust account check to you for same.

Additionally, I am enclosing my trust check for \$8.75 for another certificate of good standing (previously we requested two certificates of good standing on May 29, 2002, thinking that the corporation's status was re-instated). It is my hope that I have reached the correct department to resolve this re-instatement dilemma. Once again, thank you for your assistance. It is wonderful that you have so much available information on the internet, plus the trained staff to assist us in accessing it.
