ARTICLE I. NAME

The name of the corporation shall be:

ARTICLE V. TERM OF EXISTENCE

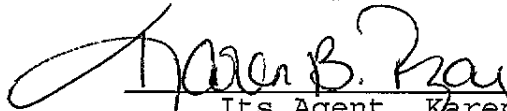
