ARTICLES OF INCORPORATION OF 3 DIGIT CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Florida, and for that purpose hereby adopt the following Articles of Incorporation:

ARTICLE I. Name. The name of the corporation is: 3 Digit Corporation

ARTICLE II. Place of Business. The address of the initial principal office of the corporation is: 3501 Keyser Avenue #66, Hollywood, Florida 33021.

ARTICLE III. Authorized Capital. The corporation shall be authorized to issue One Hundred Thousand (100,000) shares of \$1.00 par value common stock.

ARTICLE IV. Preemptive Rights. The holders, from time to time, of the capital stock of the corporation shall have preemptive rights as to the capital stock of the corporation then or thereafter authorized to be issued, including but not limited to treasury stock.

ARTICLE V. Registered Agent/Office. The name and address of the initial Registered Agent/Office of the corporation is: David Pavilack, 771 South Rainbow Drive, Hollywood, Florida 33021.

ARTICLE VI. Incorporator. The incorporator of the corporation is: David Pavilack, 771 South Rainbow Drive, Hollywood, Florida 33021. All powers, duties and responsibilities of the incorporator shall cease at the time of the delivery of these Articles of Incorporation to the Florida Department of State for filing.

ARTICLE VII. Board of Directors. The initial Board of Directors shall consist of four (4) Directors. The persons who are to serve as Directors until the first annual meeting of the stockholders, or until their successors are elected and qualified are: Paul Pavilack, 771 South Rainbow Drive, Hollywood, Florida 33021; Marc Bosen, 3501 Keyser Avenue #66, Hollywood, Florida 33021; Sanford Bosen, 3501 Keyser Avenue #66, Hollywood, Florida 33021; and Lawrence L. Pavilack, 6200 E. Thomas Road, Suite 201, Scottsdale, Arizona 85251.

ARTICLE VIII. Purpose. The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

ARTICLE IX. Liability. There shall be no personal liability on the part of the Shareholders for the debts of the corporation.

ARTICLE X. Corporate Existence. Corporate existence will begin at such time as the Articles of Incorporation are filed with the Florida Department of State.

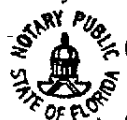
